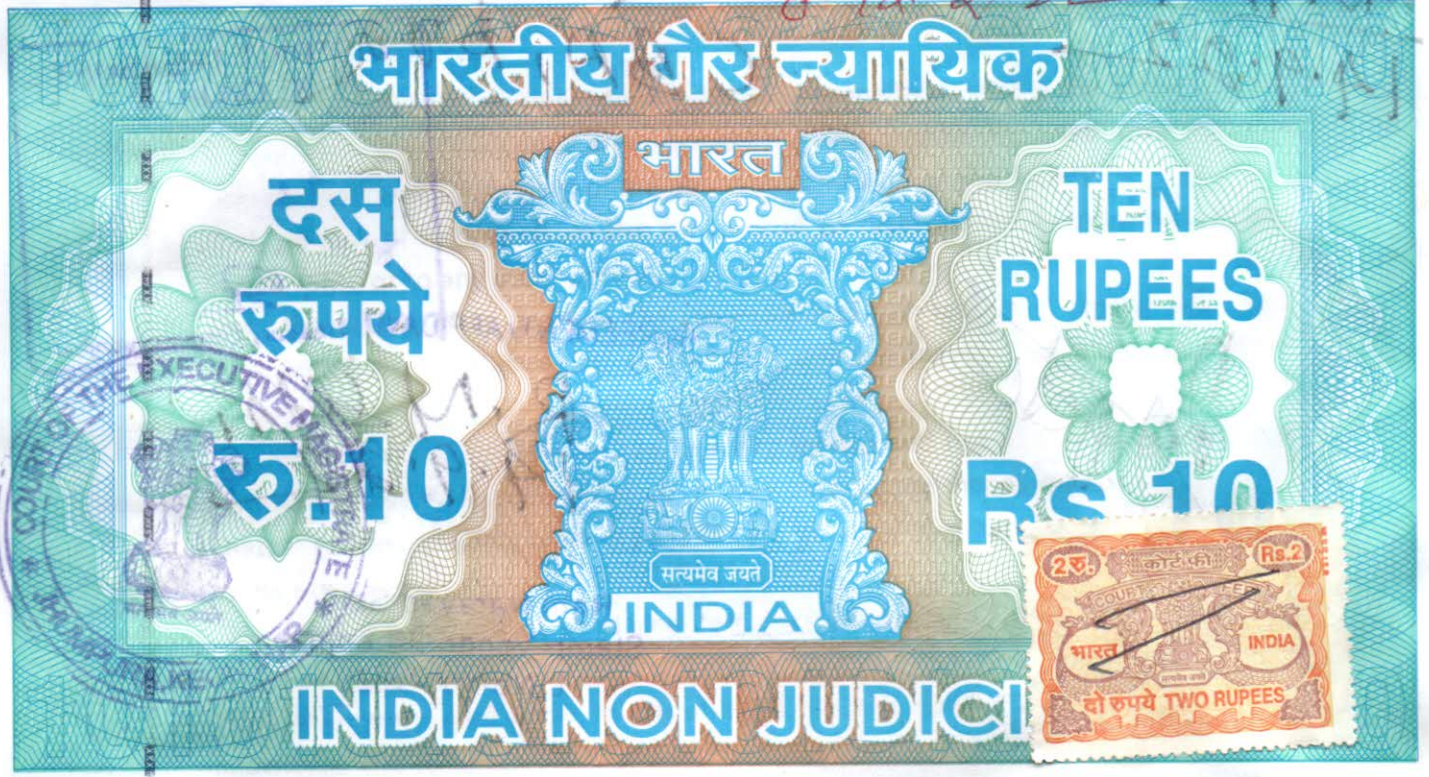

5. That, the members of the society in no way can withdraw profit coming out of the business of the society for their personal gain. The profit simply explained in business

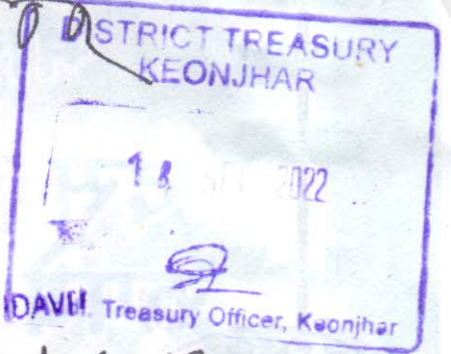
